

# WHOLESALE AGREEMENT

## SQUIMPISH FLIES

### GENERAL TERMS OF AGREEMENT

To qualify for wholesale purchases, you must be a valid retail business and by agreeing to our terms and conditions you certify that you are such. You are only authorized to sell through the retail store website and/or online sales that you have listed. Secondary stores must receive prior written approval.

### ORDER REQUIREMENTS

We ask that you spend a minimum of \_\_\_\_\_ on your initial order placed with a minimum quantity of \_\_\_ units. Subsequent orders, we ask you to spend a minimum of \_\_\_\_\_. Due to limited stock, we ask that you do not order more than **10** of the same products in order to respect production and shipping deadlines. ### PAYMENT INFORMATION

We accept payments via [*credit card, PayPal, certified checks, ...*]. Orders must be pre-paid. You will be emailed a PayPal invoice and goods will be shipped upon payment. Please note that we only hold limited stock so all orders will be held for a maximum of **14** days before being re-stocked. Orders may be canceled within **5** business days of the order placement.

### SHIPPING & HANDLING

Shipping costs may vary. Delivery is typically within **2 to 5** days upon payment. We use [*USPS, FedEx, or UPS Ground shipping*], based on cost affordability, if your shipment is damaged in transit you agree to contact *Squimpish Flies* within **5** days of delivery. Any problems must be reported in writing or by email and retailer cannot return goods until he has received a written authorization. Goods sent back without one will not be credited to your account.
